Dear President Martinez-Helfman,

We are delighted that the International Ombudsman Association has joined the National Academies' Action Collaborative on Preventing Sexual Harassment in Higher Education. As the members of the Leadership Group guiding the Action Collaborative, we recognize the importance of your commitment of campus leaders and financial resources to the urgent need to improve the way our organizations address sexual harassment and abuse. We believe that reducing and preventing sexual harassment and abuse in our communities is a challenge that requires us to collaborate and work together across institutions, and we are grateful for your 4-year commitment to this member-driven and member-funded effort.

The Action Collaborative held a great first meeting earlier this year, on June 9-10, 2019, at which representatives from the member institutions shared novel and innovative approaches and promising practices for preventing sexual harassment and abuse. The meeting also served to connect institutions working on similar topics and provide examples of the ways that institutions might organize and approach this work on campus and at research institutions. One of the important results from the meeting was the formation of four working groups and the development of plans for how the groups will approach their work on the topics of prevention, response, remediation, and evaluation.

Plans were also discussed for the first annual public summit that the Action Collaborative will host every fall in a different part of the country. The Summit is an opportunity to gather information, engage in a dialogue, gain diverse perspectives on how to effectively prevent sexual harassment and abuse, and ultimately identify and elevate promising practices for preventing sexual harassment and abuse. This year's Summit will be held on November 19<sup>th</sup> and 20<sup>th</sup> at the University of Washington in Seattle. We have shared the information about the event with your Action Collaborative representatives, and we hope that you will encourage and support them in making time and participating in this event and the ongoing work of the Action Collaborative.
